Action Plan

This document outlines the key activities, objectives and intended outcomes of the Action Plan of the EURid Youth Committee (YC) for the period of its first mandate.

Work program processes that can change the current plan:

1. YC receives .eu procedures, strategies and etc. for comment and responds in up to 2/3 weeks after they are received;
2. YC receives information about the calendar with events and planned YC participation either in person or virtually and determines who and how it will participate;
3. YC 12 months reports for the tasks that are accomplished require adjustment;
4. Online and/or in-person meetings of the Youth Committee every 3 months identify new areas of interest;

1. Youth Committee members Appointment (June 2020 - August 2020)

EURid will officially appoint the initial five members of the Youth Committee. All members of the Youth Committee shall sign the EURid Conflict of Interest statement and a commitment to serve the Committee in their personal capacity without taking influence or instruction from any third party.

EURid appoints the liaison to the Committee.

2. Youth Committee Charter Proposal and acceptance (September 2020)

EURid will ask the Committee to approve their Charter – based on a draft produced by EURid – and appoint a coordinator (at their first virtual meeting of 2020).

EURid will facilitate and support the organization of a (virtual) meeting of the Committee. EURid will suggest the first discussion points which could be:

- a. Committee Charter.
- b. Appointment of the coordinator.
- c. Participation in the 2020 IGF.
- d. Other IG related opportunities.
- e. What EURid could do differently to make the .eu domain name more appealing to younger generations.

EURid publishes a PR about the establishment of the Committee

Out of the meeting, the Committee will define a work programme with deliverables for the first two years.

- Youth Initiatives dialogue
- Attendance of other WSs and sessions

- Every member of the YC is to promote the EURid mission within his / her professional / educational network through a show-and-tell event, a blog post, etc;
- Organisation of local initiatives supported by EURid and organised by YC members.
